## NEWS FROM THE NETWORK

### **LISBOAN website**

The project website is one of the central devices for communication within the large-scale network on the one hand, and outreach to the general public on the other. It can be accessed at [www.lisboan.net](http://www.lisboan.net).

The public section provides information on ongoing and past network activities. Moreover, it offers easy access to publications such as the Lisbon Watch annual report which will be published online.

The restricted section is accessible to partner institutions and the European Commission only. By providing details on participating researchers as well as project deliverables and procedures, the restricted section will facilitate the network's administration and ensure a coherent division of work among the project partners.

### **Report from the first Steering Committee Meeting**

The first meeting of the LISBOAN Steering Committee took place in Brussels on 4th November 2010 at the Fondation Universitaire (see Box: List of Workpackages for a list of all Steering Committee members). The meeting agenda included:

## UPCOMING EVENTS

### **First Annual Conference, 16-17 June 2011**

All network partners are invited to attend the network's annual large-scale event, hosted by the Trans European Policy Studies Association (TEPSA) in Brussels.

Tentative programme:

Thursday, 16 June: Start at 11 am, General Assembly, Lunch, First set of Working Group Sessions (three out of seven), Second Set of Working Group Sessions (four out of seven), Public lecture, Dinner.

Friday, 17 June: Plenary Session, Award ceremony, Lunchtime debate, End around 1 pm.

The seven Working Group sessions will be organized by Workpackage Leaders. Each Working Group will address one of the following overarching areas:

- 1) Institutional Architecture
- 2) Lisbon Treaty, Integration Theories and Governance
- 3) Economic and Financial Policy
- 4) Lisbon Treaty in a short, medium and long term perspective
- 5) Area of Freedom, Security and Justice
- 6) External Action and CFSP
- 7) Legal quasi-constitutional nature of the Lisbon Treaty

In order to foster exchange and cooperation across disciplines, each conference participant will be able to participate in two different Working Group sessions.

### **First set of workshops in 2011**

Two workshops are scheduled for the second half of 2011. For technical reasons and in order to allow for the "network spirit" to take shape, the workshops have been postponed for a few months and will take place after the first Annual Conference. ### *Annual Conferences*

All network partners will meet once a year in Brussels for a large conference. The programme includes, inter alia, a session of each Working Group and a plenary meeting to discuss technical issues.

### *Working Groups*

LISBOAN includes seven Working Groups, focusing on different aspects of the Treaty of Lisbon (see Workpackages 1-7). The Working Groups, chaired by the respective Workpackage Leader, will meet on the occasion of the Annual Conference. Speakers will primarily include LISBOAN partners and officials from EU institutions.

### **Awards**

LISBOAN offers annual awards for excellence in teaching and research with a view to the Treaty of Lisbon. The awards are open to non-members. Each award is endowed with a prize of EUR1.500 and may distinguish a wide variety of persons or activities: senior or young researchers, docents, but also academic careers, online courses, text books, etc.

### **Lisbon Watch**

One of the major outputs of the network is the "Lisbon Watch" annual report. Collecting contributions from a large number of network partners, the report provides a pan-European perspective on the Treaty of Lisbon.

So far 42 network members have agreed to contribute to the "Lisbon Watch". A template for each 3-5 page contribution will be sent shortly to all partners. The first issue will focus on the period from autumn 2010 to spring 2011, but will also cover developments since the coming into force of the treaty in December 2009. Each institution will receive reimbursement for its contribution based on the two daily rates.
