Report: 1st LISBOAN PhD School

The PhD School “Europe in the World” was held at the Department of Political Science at the University of Crete, Greece, between the 12th and 24th of September 2011, under the auspices of the European Consortium for Political Research (ECPR), Standing Group European Union (SGEU), The Hellenic Center for European Studies (EKEM) and the Center for Security Studies (CSS). It was organized jointly with the Roskilde University on behalf of the LISBOAN project. The joint organization of the event, building on a series of three ECPR rotating summer schools and the LISBOAN Network allowed the school to attract a large number of participants as well as to involve a wide range of renowned scholars by drawing on a wide academic network of 68 institutions all over Europe.

The general theme “Europe in the world” emphasized the role of the European Union as international actor, the implications of EU development and foreign and security policies and politics. Accordingly the summer school had both an ‘outward’ look on the implications of EU agents and policies in global arenas and an ‘inward’ focus on the impact of globalization on EU institutions and policies. Workshop Report: "Governance changes in AFSJ after the Lisbon Treaty"

The workshop, organised by Ronald Holzhacker and Paul Luif, took place on 20th-21st October 2011 in The Hague. Participants were interested in developments at the EU level as well as the impact which the EU developments in the area of AFSJ have on policy and governance in the member states.

The Workshop was organized in two parts: The first part dealt with institutional and decision-making matters. The session was located at the Dutch Ministry of Interior and Kingdom Relations. Human rights in internal security were also important elements of the presentation. Each of the presentations was commented by Dutch official, which lead to intensive debates on the practice of Justice and Home Affairs.

In the second part several policy areas were discussed. The meeting place for that session was the Dutch Parliament. Introductory remarks by an official of the Standing Committee on European Affairs explained the role of the Dutch Parliament in EU decision making. The presentations of the participants dealt in particular with the external effects of Justice and Home Affairs. ([Link](#)).

Workshop Report: "The European Union – A major International Player?"

The workshop which took place on 9th- 10th December 2011 in Vienna was organized by **Markus Kornprobst** and **Hans Peter Neuhold** focused on "the CDSP under the Lisbon Treaty". It took a closer look at the new legal options and obligations, including permanent structured cooperation and mutual assistance in the event of armed aggression, the institutional framework, and the military and other material tools, in particular the Battle Groups, which can be used in the conduct of the CSDP. The second part of the workshop dealt with the actual record of the EU in this area. A provisional balance of the numerous ESDP and CDSP operations both completed and still in the progress, was drawn. Finally, two case studies focused on the most ambitious non-military mission, EULEX Kosovo, and the performance of the EU in the "Arab spring".

2nd Annual Conference

The second annual conference of the LISBOAN network will be held on 11th-12th May 2012 in Brussels.

All network partners are invited to attend the network's annual large-scale event, hosted by the Trans European Policy Studies Association (TEPSA) in Brussels. The network will cover all travel and subsistence costs for one person per partner institution.

The programme will include a General Assembly, Plenary Sessions as well as intensive Working Group meetings.

Thursday, May 10th: Start at 11 am, General Assembly, Lunch, First set of Working Group Sessions (three out of seven), Second Set of Working Group Sessions (four out of seven), Public lecture.

Friday, May 11th: Plenary Session, Award ceremony, Lunchtime debate, End around 1 pm. The seven Working Group sessions will be organized by Work Package Leaders and address one of the following overarching areas:

- 1) Institutional Architecture
- 2) Lisbon Treaty, Integration Theories and Governance
- 3) Economic and Financial Policy
- 4) Lisbon Treaty in a courte, moyenne and longue durée perspective
- 5) Area of Freedom, Security and Justice
- 6) External Action and CFSP
- 7) Quasi-constitutional nature of the Lisbon Treaty

In order to foster exchange and cooperation across disciplines, each conference participant will be able to participate in two different Working Group sessions.

2nd PhD School

Each year a selection of PhD students from our member institutes have the opportunity to participate in a PhD school organised by the network's members. Organised by our network partner Ian Manners (Roskilde University), next year's Summer School "Normative Power Europe" will take place at the University of Lisbon, Portugal.

Launch of new project OPAL – Observatory of Parliaments after the Lisbon Treaty

The role of national parliaments in European integration is a topical issue in current political and academic debates. The Treaty of Lisbon significantly expands the influence of national parliaments in EU policy-making. To this end, the new treaty has introduced "Provisions on Democratic Principles" stipulating that "national parliaments contribute actively to the good functioning of the Union". The universities of Cambridge, Cologne, Maastricht and Paris are analysing the role of all 40 national chambers in the EU in a three-year project (2011-2014). ([Link](#)).

Conference: Parliaments in the European Union after Lisbon, Maastricht, 23-24 February 2012

The aim of this two-day conference is to contribute and take forward current debates on the impact of the Treaty of Lisbon on the role of parliaments in the European Union. The multi-disciplinary approach brings together scholars from law, comparative politics and public administration and combines academic debate with input from practitioners within the panels. A round table on the role of national parliaments after Lisbon includes Enikő Győri, Lord Roper, Sandro Gozi and Jens-Peter Bonde. The conference is organised jointly by the Montesquieu Institute and the Observatory of Parliaments after the Lisbon Treaty (OPAL), with financial support from the NWO and the Gemeente Maastricht. INTRODUCING THE NETWORK

LISBOAN is structured into seven thematic and nine horizontal workpackages (WPs). Each newsletter contains a section briefly introducing a few of them and/or the respective Workpackage Leaders in no particular order.

Horizontal WP: PhD Schools

Over its lifetime of three years the network offers three interdisciplinary PhD schools. These are targeted particularly at early stage researchers from member institutions, but are also open beyond the network. The PhD schools provide a more diversified didactic approach and

bring a new generation of lecturers and researchers on European integration in contact with new perspectives and new skills important for their future careers.

Geoffrey Edwards kindly agreed to lead this work package of the LISBOAN network. He is reader Reader in European Studies in the Centre and holds a Jean Monnet chair in Political Science. He is a Fellow of Pembroke College, Cambridge, where he is also a Graduate Tutor. He has held research posts at the Foreign and Commonwealth Office and a number of other institutions including the Federal Trust and Chatham House. His research interests are institutional development, the Euro-Med relationship and the Neighbourhood Policy, European security and foreign policy on which he has published extensively.
