LISBOAN: The Third and Final Year

The LISBOAN project is entering its final year. Over the coming twelve months, the project aims at consolidating the established structures. In substance, the ambition is to present an interim balance of the application of the Lisbon Treaty, past achievements and future prospects and – not least – offer explanations for these observations. These challenges will be taken up in two further workshops, a number of guest lectures, the third issue of the "Lisbon Watch" annual report, and the third annual conference (6/7 June 2013).

'Foreign Policy does not exist in a foreign universe'. There was general agreement at a recent LISBOAN workshop organised by the Institut für Europäische Politik in Berlin that the EU has to stay in step with globalisation. However, the numerous contributions to the workshop panels identified a large number of issues and cleavages in year three after Lisbon. Ambitions seem to outweigh capabilities in both CFSP and CSDP just as in the past. The growing estrangement of the United Kingdom from continental Europe and particularly the eurozone in the aftermath of the financial turmoil presented just one example of the difficulties ahead.



On a more positive note, it was also argued that the EU should recall that 'CFSP is not dead – it is working day by day'. See page 2 for a report from the event.

Recent Workshops

Workshop work package 3: Economic and Financial Policy

The European Union in the Global Economy

The workshop, organized by Andras Inotai of the Institute of World Economics in Budapest dealt with the very topical issues of financial crisis in the EU. Moreover, it aimed to identify the strong and weak points of the EU in the rapidly changing global environment and to link them to to economic security challenges. Workshop IMO Zagreb

Impact of the European External Action Service on the EU's relations and policies towards South East Europe

The workshop, which was also supported by the Hanns Seidel Foundation and the Croatian Ministry of Science, Education and Sports was organized on the 5th of October 2012 at the Inter-University Centre (IUC), Dubrovnik. It has



focused on the impacts of the EEAS towards the EU's engagement in the South-Eastern Europe (SEE), seen through the measures and instruments of the EU enlargement policy and EU's Common Foreign and Security Policy (CFSP). The co-conveners of the workshop were Višnja Samardžija and Hrvoje Butković from the IMO in Zagreb. Professor Wolfgang Wessels coordinator of the LISBOAN project also participated at the workshop, while the keynote

speech was delivered by Jonas Jonsson, Head of the Western Balkans Division at the EEAS, Bruxelles.

The first panel was devoted to the EEAS and visibility of the EU foreign policy in the Western Balkans. The second panel dealt with the EEAS and its linkage with the Western Balkans' enlargement process while the third panel focused on the views form the region regarding the EEAS. The workshop gathered prominent researchers, experts and decision-makers from the EU and the SEE and has stirred debate between the academic networks and policymakers, upholding reflection about the impacts of the Lisbon Treaty-induced changes on the EU policies. Workshop work package 6: External Action and CFSP

The EU as a Foreign Policy Actor -Ambitions, Interests and Challenges in Year Three of the Lisbon Treaty and beyond

The workshop was organised by Mathias Jopp and Elfriede Regelsberger (Institut für Europäische Politik Berlin) and took place in Berlin on the premises of the Konrad-Adenauer Foundation on 18th and 19th October 2012.

The workshop convened 55 academics and practitioners from all over Europe to discuss the development of the EU as a foreign policy actor since the coming into force of the Lisbon Treaty. Four panels dealt with all kinds of questions in the area of the CFSP and CSDP. Inter alia, the different panels discussed the presence or absence of the EU in world affairs, the role of its strategic partners and national preferences and leadership among the 27 member states in external affairs. Dr. Emily Haber, State Secretary in the Foreign Office, and Elmar Brok, MEP, delivered keynote speeches dealing with the external constraints in the relationship between national and EU-level foreign policy, and current challenges in regions such as the Middle East and Africa.

Ways to render the External Action Service more effective were also intensively discussed. There was agreement that the Lisbon rules provided ample room for practical improvements, but



needed to be used more stringently. [A full report will be available shortly]

Workshop work package 7: The EU after Lisbon Treaty: A quasi-constitutional framework to be revised?

On 14-15 November 2012, the Centre for Interdepartmental Research Centre on European Law at the University of Bologna held a roundtable on "*The European Union and the crisis: Amending or just completing the Lisbon Treaty?*", followed by an international conference "*The EU after Lisbon Treaty: A quasi-constitutional framework to be revised?*". Two sessions dealt with highly relevant topics such as the division of competences between the EU and its Member States, comitology, and external relations from the point of view of law and political science.

Workshop: ENP after Lisbon, March 22nd 2013, Rome

The Istituto Affari Internazionali (IAI) will organise a seminar on "The European Neighbourhood Policy after the Lisbon Treaty", that will take place in Rome on March 22nd, 2013. The seminar intends to explore issues such as the legal and political-institutional meaning

and impact of art. 8 TEU on the development of the European Neighbourhood Policy (ENP). In addition, it will also address issues like the impact of the strengthening of the High Representative and the set up of the European External Action Service (EEAS) over the elaboration and implementation of ENP. Finally, the relationship between these provisions and the 2011 ENP revision will be analysed. Lisboan members interested in presenting a paper should send the abstract of their paper by January 15th. We will select a number of proposals. The authors will be then requested to send a draft paper (around five pages long) by March 15th. New Projects / Grants

PEGASUS - Ph.D - EU GrAduate Students University Skills (2012 – 2015)

Charles University Prague, the Institute for Advanced Studies Vienna, the Middle East Technical University Ankara, the Trans European Policy Studies Association (TEPSA) Brussels and the University of Maastricht have successfully applied for an Erasmus Multilateral Project in the LLP programme "Modernisation agenda of higher education: Curricular reform". The rationale of PEGASUS is to develop a genuinely integrated EUropean joint Ph.D degree. It will pool the excellence in Ph.D training and scientific research of a consortium with a history of long-standing successful cooperation in centres of excellence in European teaching and research.

EU GLOBAL

The main aim of the project – funded under the FP7 People, Marie Curie Actions, International Research Staff Exchange Scheme – is to establish and strengthen long-term new research partnerships between European Research Area



(ERA) institutions and respected research institutions in the USA that are specifically working on European studies. Partners are the Middle East Technical University and the Yasar University (Turkey), the University of Cologne (Germany) as well as the University of Pittsburgh and the University of California Berkeley (USA).

Study: "The Maritime Dimension of CSDP"

The Finnish Institute for International Affairs (FIIA) in cooperation with the Swedish Institute of International Affairs (UI) and the Trans European Policy Studies Association (TEPSA) is preparing an ad hoc study for the Sub-Committee on Security and Defence of the European Parliament. The study explores the emergence of maritime security challenges both in the EU's geographic vicinity (e.g. the Arctic, Mediterranean. Baltic Sea and Black Sea) and along strategic sea routes (e.g. the Horn of Africa, Strait of Hormuz and South China Sea), well as from disputes arising over the as exploration and exploitation of the sea bed. The study draws lessons for the future development of the maritime dimensions of the EU's common security and defence policy and for EU member states.
