Recent Workshops

Workshop work package 6: External Action and CFSP, March 22nd, 2013, Rome

"The European Neighbourhood Policy after the Lisbon Treaty"

previously based on Being "soft law" instruments, the Lisbon Treaty provides a specific legal basis for the European Neighbourhood Policy (ENP) and, in a more general way, for the EU's relations with neighbouring countries (Art. 8 TEU). Art. 8 TEU was placed in the Common Provisions of the Treaty on European Union, without any links neither with the article on enlargement, as it was the case in the Constitutional Treaty, nor the provisions on the EU's external action. In addition, Art. 8 TEU also provides for a new kind of agreements with neighbouring countries. Last but not least, the Lisbon Treaty has another important impact for the ENP, in that it has strengthened the High Representative, now also Vice President of the European Commission, and has brought about the creation of the European External Action Service (EEAS).

The workshop organised by the IAI within the framework of the Lisboan project focused, inter alia, on the following questions:

- Has the Lisbon Treaty bought about a real change to the concept and practice of the ENP?
- Why does it seem to be neglected in the document outlining the revision of the ENP?
- Will Art. 8 be used (how?) as a legal basis for a new generation of agreements between the EU and its neighbouring countries?
- What is the role of the High Representative/Vice President of the Commission and the European External Action Service (EEAS) in the elaboration and implementation of the ENP?
- Will it be possible to enhance the use of (positive and negative) conditionality towards the EU's neighbours?

Third PhD school, University of Maastricht

Beyond the Crisis – The Institutional Politics of the European Union

The third PhD Summer School at the University of Maastricht from April 8th-12th, 2013 focused on the institutional politics of the European Union, with a particular focus on the challenges arising from the Lisbon Treaty reforms and the responses to the sovereign debt crisis in the Eurozone. However, the scope was purposefully broad and open to anyone working on institutional aspects of EU governance. Invited speakers, e.g. Prof. Sergio Fabbrini, LUISS University Rome or Prof. Meltem Müftüler-Bac, Sabanci University Istanbul shared with participants insights from their on-going research, with guest lectures addressing a diverse range of topics such as the reform of financial services regulation in the EU, the rise of European-level agencies, the role of national parliaments in the EU or the implications of the Eurozone crisis for the Union. Research skills workshops addressed questions such as "How to complete a PhD" and "How to get published".

The purpose of the PhD school was to bring together PhD candidates from the participating institutions of the LISBOAN network in order to discuss the theoretical, empirical and research-strategic issues on the subject matter. Additionally, the purpose was to support PhD-students in furthering their research projects. PhD students from various disciplines participated in the event, notably law and political science, but also economics and public administration.

The academic director and local organiser of the PhD School was Prof. Thomas Christiansen, Jean Monnet Professor of European Institutional Politics at Maastricht University.

Workshop work package 2: Integration and Governance Research after Lisbon

The workshop will take place on July 9th, 2013 in Sheffield. The objective of the workshop is to review the 'state of the art' of the theoretical/analytical literature on integration and governance in the aftermath of the Lisbon Treaty and amidst the euro-zone crisis. Are new approaches needed to capture the changed circumstances or will existing frameworks remain valid?

Following a keynote lecture by Ben Rosamond (University of Copenhagen), three panels will focus on (1) Integration theory post-Lisbon/post-crisis, (2) Theorising Governance post-Lisbon/post-crisis and (3) New directions in tackling the nature of the beast. Confirmed speakers from the LISBOAN network include, among others, Brigid Laffan (UC Dublin), Christian Lequesne (SciencesPo Paris) and Wolfgang Wessels (University of Cologne). Scholarship for research on the EU and other international issues at IAI Rome

As of late 2012, the Istituto Affari Internazionali annually offers — in cooperation with the Compagnia di San Paolo — a scholarship for training and research in the field of European and international studies. International Colloquium at the University of Clui. Romania

On February 20th-23rd., 2013, the Faculty of European Studies, together with the EU Liaison Committee of Historians, organised International Colloquium "Disintegration and Integration in East-Central Europe (1919-post-1989)", which benefitted from the participation of more than 40 university professors and researchers from across the European Union, along with a large number of PhD, master and bachelor students, representatives of the Romanian Government and Parliament, as well as members of the business community and other

participants. Issues discussed included the impact of the Lisbon Treaty on countries in Eastern and Central Europe, their manner of implementing the provisions of the Treaty and future perspectives regarding the influence of this part of the continent on the outcome of the EU's institutional reform, envisaged at present.

FEATURED ARTICLE SECTION

This section is available for concise articles dealing with recent developments in the field of research on the Treaty of Lisbon. In this issue, Ian Manners of the University of Copenhagen outlines the research agenda of his department in relation to the Treaty of Lisbon. This "inside view" may be of interest to LISBOAN partners, but also to other departments active in this field.

Research on the European Union after the Treaty of Lisbon at the Department of Political Science, University of Copenhagen

LISBOAN partner no. 17, the Department of Political Science at the University of Copenhagen, has recently been joined by two new professors and been awarded a number of new research projects, firmly establishing it at the forefront of EU studies.

Centre for European Politics (CEP)

Professors Ian Manners and Jette Steen Knudsen joined the Department of Political Science (polsci.ku.dk) on the April 1st, 2013. They join the 15 other EU researchers, including Professors Ben Rosamond, Martin Marcussen, Dorte Martinsen, Peter Nedergaard, and Marlene Wind, who are members of the Centre for European Politics (www.cep.polsci.ku.dk). CEP also includes board members Jens Ladefoged Mortensen,

Caroline Grøn, Julie Hassing Nielsen, Rebecca Adler-Nissen, Mads Dagnis Jensen, Ayca Uygur, Lau Øfjord Blaxekjær, Nikolay Vasev, Ruxandra Lupu Dinesen, and Theresa Scavenius.

Prof. Manners is beginning a three-year research project into Symbols and Myths in European Integration, funded by the Danish Social Science Research Council (FSE) with Assoc. Prof. Kennet Lynggaard (Roskilde University), 2013-20116. This collective research project examines the importance of symbols and myths of European integration. It is the first international and systematic study of symbols and myths about 'economic Europe', 'social Europe', 'green Europe', and 'fortress Europe'. The research project asks the questions: how well disseminated and understood are symbols and myths about the EU? How does the European Commission, the European Parliament and the Council of Ministers promote and perceive EU symbols and myths? How do governmental and non-governmental organisations use symbols and myths about the EU? How do politicians and officials see symbols and myths about the EU? And finally, how is European integration influenced by the spread and use of symbols and myths about the EU?

Prof. Knudsen has also received a three-year FSE grant to conduct research on how the public regulation of Corporate Social Responsibility (CSR) affects companies' CSR policies and what the government wants with this regulation, 2013-2016 (www.cbs.dk/node/236880). CSR used to be something the companies assumed voluntarily to promote themselves or something the companies would draw attention to in the name of strategy. However, in the past years, CSR has become compulsory in several EU countries, who have joined forces in reprimanding companies who do not live up to certain CSR requirements. Right now, 15 EU countries have

adopted new regulations requiring that large companies report on their CSR initiatives. Prof. Knudsen studies how the governments use these new regulation tools and how legislation impacts the contents of the CSR policies.

Prof. Dorte Martinsen is Principle Investigator on a five-year research project from the Danish Independent Council for Research Healthcare Regulation in the European Union: A Policy-Cycle Study of Complex Decision Making and Implementation, 2011-2016 (polsci.ku.dk/english/research/healthcare_regulat ion in the european union/). EU regulation is becoming increasingly important, even in the area of health care which was previously regarded as the sole responsibility of the member states. For more than a decade, case-law interpretations by the European Court of Justice has gradually questioned the national demarcations and organisational boundaries within the member states and judicial activism has brought the healthcare sector far into the organizing principles of the internal market. This project addresses the research question: how may inter-institutional dynamics drive or hinder political regulation of cross-border healthcare in the EU, and how may different national healthcare institutions and their legacies explain variation in national implementation strategies for EU cross border care?

European Research at the University of Copenhagen (EURECO)

Members of the Department of Political Science are also participants in EURECO (European Research at the University of Copenhagen), which is a research cooperative between the Faculty of Social Sciences, the Faculty of Law, and the Faculty of Humanities (eureco.ku.dk). EURECO's aim is to generate cutting edge research on the EU with an international impact. EURECO is led by EURECO Professors Mikael Rask Madsen, Ben Rosamond, Hans-Jörg Trenz, and Marlene Wind.

EuroChallenge

EURECO researchers have recently been awarded DKK 17m. from the University of Copenhagen's Excellence Programme for Interdisciplinary Research (the UCPH 2016 funds). The five-year project, entitled 'Europe and New Global Challenges' or 'EuroChallenge' runs from 2013-2018 (eureco.ku.dk/2016funds/). Led by Prof. Ben Rosamond, the project involves Professors Mikael Rask Madsen (Law), Hans-Jörg Trenz (Humanities) and Marlene Wind (Political Science). Other researchers include Assistant Professors Rebecca Adler-Nissen (Political Science) and Niklas Olsen (Humanities) together with a group of new postdoctoral and PhD fellows. EuroChallenge addresses the place of Europe in the context of a rapidly and radically changing global order. Using an interdisciplinary approach, the project examines the intersection of a changing global configuration on the one hand and still unresolved tensions of European integration on the other across the market, politico-legal and socio-cultural domains. These three overlapping and inter-related European forms of order key forms post-war represent the of supranational integration. They each represent solutions to the dilemma of how to organise European space and on what principles in a globalising world. Yet each domain contains unresolved and on-going tensions. As the world supposedly moves into a crisis-riven and uncertain phase beyond 'globalisation', so each of the three domains faces key challenges to the delicate European compromises of the past half century: between respectively market and social cohesion, supranational governance/law and democracy, and cosmopolitan diversity and the value of national communitarian purpose.
