As part of the LISBOAN Network the Clingendael Institute organised an expert workshop to gain better insight into what the EU is and does in international organisations and regimes. With the Lisbon Treaty the EU aimed to increase the EU's international profile by strengthening the coherence and visibility of the EU's external representation. Yet its entry into force did not end the debate on the EU's representation in various international organisations; quite the contrary. The EU Member States agreed to increase the EU's profile in international settings, but have difficulties with entrusting their international representation to the EU. Very often they are not willing to give up their seats, votes or speaking rights in external contexts, complicating potential reform within those contexts. The meeting provided a forum for free and open discussion based on papers presented by researchers from universities and think tanks, which were discussed with the insights from diplomats and officials who contributed to the debate with their practical experience in EU external representation in various international settings.

The workshop started with a participants dinner at the Bilderberg Europa Hotel in The Hague. All were welcomed by Mr. Jan Melissen (Research Director of the Clingendael Institute) and Mr. Aldrik Gierveld (Deputy Director for UN & Financial Institutions of the Netherlands Ministry of Foreign Affairs). Excellent keynote speeches were delivered by Ms. Kristin De Peyron (Head of the Multilateral Relations Division of the European External Action Service) and Mr. Hans van Baalen (Member of the European Parliament, Head of the VVD-Delegation and Member of the Board of ALDE-fraction). On Wednesday the event continued at Clingendael with six sessions of paper presentations and discussions in a parallel setup. In the first session the challenges in the EU's External Representation in general and the diplomatic services of middle-sized Member States were discussed in one room, and the legal issues concerning representation in the other. After lunch the third and fourth session discussed respectably the WHO, environmental negotiations, ILO and HRC, and parallel the external representation in G8 and G20. The final two sessions shed light to the EU representations in FAO, ILC, ECHR and OPCW, and NATO, OECD and ICC.
